New Freedom Transportation Program Update

The year 2008 proved to be very busy for the Transportation Department! Through the three programs, Coalition, New Freedom Volunteer Driver and Voucher, 3,449 rides were given to 238 elderly and persons with disabilities. The counties that have been served in 2008 are St. Croix, Dunn, Chippewa, Eau Claire, Pierce, Clark and Pepin. New riders with transportation barriers continue to enroll daily! The New Freedom programs are gearing up to expand their transportation programs to serve the rest of their 10 county service area by March. The new counties that will be included in the expansion of transportation services include Rusk, Barron, and Polk. Plans are also being made to update the Center for Independent Living's current website to include transportation services. A comprehensive 10 county service provider list is being created to help coordinate regional transportation efforts and will debut soon on the website!

Volunteer Driver Program of St. Croix County

The Volunteer Driver Program of St. Croix County provides transportation to persons with disabilities and the elderly in St. Croix County. Most of our trips are for medical and counseling appointments, however, we also give rides for those who need to engage in independent living activities (shopping, banking, etc), for social/recreational purposes and employment-related needs that enable riders to access and participate in their community. During 2008, we served 107 consumers and made 1,154 trips!

For 2009, we anticipate serving 120 consumers and making over 1300 trips. **WE NEED MORE VOLUNTEER DRIVERS!** Our riders all live in St. Croix County, but we take them both within the county and to places like Eau Claire, Stillwater and the Twin Cities. You would set your own schedule and determine where you are willing to travel. You would receive mileage reimbursement at the Federal rate (currently 55 cents per mile) and reimbursement for any meals or parking incurred during the trip. Since there is no salary, the reimbursement is not considered "earned income" so it would not affect any Public Assistance you may be receiving (like SSI, subsidized housing, food stamps, etc).

WisTech Loan and Demonstration Program

Auto Hand Grip: this handgrip attaches to car or truck headrest. Assists with getting in and out of the back seat.

Soft Swivel Seat: portable seat cushion which turns a full 360 degrees to assist with getting in and out of the car

Knife guard Safety Handle: the handle attaches to the end of most knives to allow you to easily push down with both hands. Helps with cutting produce

Book Stand with 2x Magnifier: combination book stand with fresnel magnifier provides a large 10" x 12" adjustable magnifier on a sturdy book stand.

Large Button Remote: Control up to four devices. Buttons are extra large, measuring 5/8". Characters are black and are in high contrast to the white buttons. Keys light up.

Jumbo Talking Calculator: 8x11" size with 7/8" high display numbers. Easy to find soft rubber buttons measure 1 1/16" x 7/8"

INVOCA Voice Activated Remote Control recognizes up to 25 user programmable voice commands. Recharge cradle for constant power. Controls TV, VCR, DVD, Cable Satellite and AUX by sound of voice

Lifetime Voice Calendar Talking Organizer: Announces pre-recorded reminders for the day. Large 3/4 "numeric, month and function buttons. Record important dates and appointments in your own voice.

ALNAMAR Home Pill Dispenser: stores up to a month's worth of medication. Easily mounts on wall or refrigerator. Pills are released into a bottom cup for easy access

Knork®: fork/knife combination cuts food with simple rocking motion. The outer tines are beveled like a knife, but not as sharp. The finger platform in the middle of the utensil provides additional leverage

Covered Spoons: lid covers approximately 2/3 of spoon to assist with keeping food on spoon

Two Liter Handle: this handle makes it easier to pour from two liter bottles

Versa Tray: this lap tray has a patented Tip'n Grip non-slip surface that keeps items in place when tray is tilted or bumped. The tray surface is 15 x 11" and includes a raised lip on tray. The pillow bottom of the tray molds to your legs and stabilizes the tray.

Easi Grip™ Long Reach Trowel and Easi Grip™ Cultivator: The unique handle design helps prevent injury to hand and wrist. The long reach tool weighs about one pound. Bright yellow handle lets you find the tool that you have put down in the garden or shed.

Oxo Good Grips Gel-e Trowel: incorporates a gel material in the tool's soft, non-slip handle. The gel flexes to provide cushioning when digging.

Add on Handles: attaché these handles to other tools such as hoes, rakes, mops, brooms, etc. to make less bending and twisting and a more comfortable grip.

Weighted Writing Pen: offers control to individuals who have problems holding or handling writing instruments

Keys –U-See Keyboard: full size keyboard- yellow keys with black print- easily seen even in low light

Arm Rests: attaches to almost any desk or table. Padded leather rest supports your forearm. Pivots and swivels to your ideal position

This program is part of the WisTech network of Device Loan and Device Demonstration programs. WisTech is funded through a federal grant, administered by the Wisconsin Department of Health and Family Services.

Disability Rights Wisconsin Family Care and Partnership Ombudsman Program Now Available

Disability Rights Wisconsin's *Family Care Ombudsman Program* is now available for persons age 18-59. It can provide assistance regarding eligibility, services or other Family Care and Family Care Partnership concerns. The Wisconsin Board on Aging and Long Term Care (BOALTC) will continue to provide its ombudsman services to Family Care and Partnership enrollees and potential enrollees age 60 and over.

The Family Care Ombudsman Program offers many services, including:

- Investigating complaints
- Resolving and mediating issues
- Providing information and education on consumer rights
- Assisting in negotiating care plans
- Appealing denials of services or changes in services that clients don't agree with
- Working with enforcement and regulatory agencies

The Family Care Ombudsman Program has staff in DRW's Madison, Milwaukee and Rice Lake offices and is available to advocate for Family Care and Family Care Partnership participants in *any* Wisconsin Family Care county. It can help Family Care and Family Care Partnership enrollees or potential enrollees, their guardians and families with issues such as:

- Development of a Care Plan that supports their goals
- Reduction in Services
- Employment
- Living Arrangement
- Young Adults Moving from School to Adulthood and enrolling in Family Care or Partnership

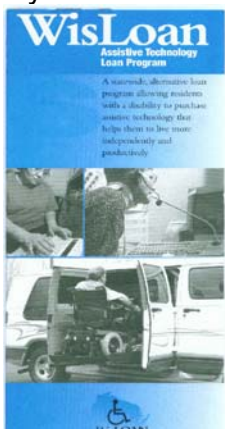

CILWW MISSION STATEMENT

The mission of the Center for Independent Living for Western Wisconsin, Inc. is to empower persons with a disability to achieve full participation in society. The mission embodies the philosophy that this may be achieved through advocacy and provision of quality consumer controlled service.

WisLoan and Telework Programs

The WisLoan program offers loans for assistive technology. The loans help people buy equipment such as hearing aids, modified vehicles, wheelchairs and ramps. The program is open to Wisconsin residents of all ages who have a disability. There are no income requirements, and individuals are not required to exhaust personal or public funding. Under the program, banks provide loans at a fixed rate of 5% to qualified borrowers. Loan amounts depend on the item purchased and the ability to repay the loan.



The Wisconsin Telework Loan Program is a statewide, alternative loan program that allows Wisconsin residents with disabilities to purchase computers and other equipment needed to work from home or from other remote sites away from the office, such as work on the road or at a telework center.
