The Jacki Rickert Medical Marijuana Act

Using medical cannabis to treat debilitating illnesses remains a crime under current Wisconsin law. The Jacki Rickert Medical Marijuana Act would protect Wisconsin patients from arrest and prosecution and allow them or a designated caregiver to possess and grow a small amount of cannabis for medical use.

The Jacki Rickert Medical Marijuana Act has been introduced by Rep. Mark Pocan (D-Madison) and Sen. Jon Erpenbach (D-Middleton).

Passing the JRMMA is a grass roots effort. If you are interested, contact your Wisconsin State Assembly Representatives and State Senators and ask where they stand on JRMMA when it gets a floor vote.

What comes next?

The two committees, the Assembly Committee on Public Health and the Senate Committee on Health, Health Insurance, Privacy, Property Tax Relief, and Revenue must now deliberate and vote on the bills. Only when the bills are voted out of committee will the JRMMA move to the floor of each chamber, the Assembly and the Senate, for a floor vote. (**Assembly Bill 554, Senate Bill 368**)

Medical Assistance Purchase Plan & Health and Employment Counseling

- Did you recently get approved for SSDI?
- Do you have a 2 year wait for Medicare?
- MAPP may be an option for you. If you have a disability determination and are working 1 hour or more per month for pay or in-kind support, this could be an option for you to purchase Medicaid. If you are not employed, you could become eligible by having an approved Health & Employment Counseling (HEC) plan.

WisLoan and Telework Programs

The Wisconsin Telework Loan Program is a statewide, alternative loan program that allows Wisconsin residents with disabilities to purchase computers and other equipment needed to work from home or from other remote sites away from the office, such as work on the road or at a telework center.

The WisLoan program offers loans for assistive technology. The loans help people buy equipment such as hearing aids, modified vehicles, wheelchairs and ramps. The program is open to Wisconsin residents of all ages who have a disability. There are no income requirements, and individuals are not required to exhaust personal or public funding. Under the program, banks provide loans at a fixed rate of 5% to qualified borrowers. Loan amounts depend on the item purchased and the ability to repay the loan.

TEPP OUTREACH GRANT 2010

CILWW maintains a device Loan and Demonstration Program which has specialized telephones and communication devices available for a person to try out to determine what works best for them. Staff will assist with TEPP) applications or provide information on purchasing equipment.

DISABILITY RIGHTS WISCONSIN OFFERS FAMILY CARE AND IRIS OMBUDSMAN PROGRAM

Do you need help in understanding your Family Care, Partnership or IRIS services or benefits?

Are you confused about your rights under Family Care, Partnership or IRIS?

Are you satisfied with your care plan or services?

Are you receiving services that meet your needs and support your outcomes?

Do you have questions regarding your cost share?

Disability Rights Wisconsin's (DRW's) *Family Care and IRIS Ombudsman Program* is now available. It can provide assistance regarding eligibility, services or other Family Care, Partnership or IRIS concerns. The Wisconsin Board on Aging and Long Term Care (BOALTC) will continue to provide its ombudsman services to Family Care and Partnership enrollees and potential enrollees age 60 and over.

An Ombudsman (OM-budz-man) is an advocate. If you are applying for or receiving Family Care, Partnership or IRIS, you are eligible for DRW's Ombudsman services. The ombudsman can assist you whether you are living in your own home, a supported apartment or another residential setting. If you are applying for or already enrolled in the Family Care, Partnership or IRIS programs and have a question or concern, call DRW at one of the toll-free numbers at the end of this article.

The Family Care Ombudsman Program offers many services, including:

- Investigating complaints
- Resolving and mediating issues
- Providing information and education on consumer rights
- Assisting in negotiating care plans
- Appealing denials of services or changes in services that you don't agree with
- Working with enforcement and regulatory agencies

The Family Care and IRIS Ombudsman Program has staff in DRW's Madison, Milwaukee and Rice Lake offices and is available to advocate for Family Care, Partnership and IRIS participants in *any* Wisconsin Family Care county. It can help Family Care, Partnership and IRIS enrollees or potential enrollees, their guardians and families with issues such as:

- **Development of a Care Plan that supports your goals**: Were you actively involved in developing your care plan? Were your concerns and questions addressed? Does your team understand what kind of life you want your long term care services to help you achieve? Did you get good information about all of your services (such as employing your own caregivers)? Were you given the opportunity to direct some or all of your services (such as employing your own caregivers)? Do you understand how decisions about your services were made?
- **Reduction in Services**: Have you requested services that are not provided? Were any previous services changed or reduced? If so, do you understand why?
- **Employment**: Are you interested in having a job or working toward employment? Are you getting support in getting or keeping a job?
- **Living Arrangement**: Are you living where you want? If you want to move, have you told your care team about that? Is your care team helping you live where you want? With whom you want?
- **Young Adults Moving from School to Adulthood and enrolling in Family Care or Partnership**: If you are at least 17 years and 9 months old, do you know that you might be

eligible for Family Care or Family Care Partnership? Are you getting information about your options for services?

If you are age 18-59, are applying for or are enrolled in the Family Care, Partnership or IRIS programs and have a question or concern, you can contact the Family Care Ombudsman Program at the Disability Rights office nearest you:

Peer Specialist Employment Opportunities in the Mental Health System

Have you ever wondered how you could use your mental health/illness experiences as a tool for employment? Have you ever thought about how your experiences could help others? Did you know that you are gaining valuable knowledge that can have an impact on the mental health system here in Wisconsin as well as have an impact in peoples' lives? Have you considered getting paid for what you may be currently doing as a volunteer? If you answered "yes" to any of these questions, then becoming a peer specialist may be an employment choice for you!

Read below on how a person can become trained to be a peer specialist...

Peer Specialist Training

To become a peer specialist, according to the META curriculum, a person would need to complete 70 hours of training that is delivered over 5 weeks. This may seem like a lot of hours and dedication; however, once a person graduates from the training, they become eligible to take the certification exam.

Wisconsin's Property Tax Deferral Program

This is a program administered by Wisconsin Housing and Economic Development Authority (WHEDA) for those who are a homeowner 65 & older with a total household of no more than \$20,000. The max annual loan is \$2,500. If there is a co-owner or spouse, the other person must either be at least 60 or either person has a permanent disability. The lien limit on the home is 33% of the assessed value, so if the person already has other liens on the home (such as a mortgage), it is likely the person will not qualify for this program.

Think of it as a home equity loan that doesn't have to be repaid until the ownership transfers or the participant doesn't live in the home anymore. The loan, with interest, is to be repaid from the proceeds of the estate or the sale of the property. The person can continue using this program year to year as long as the household qualifies and the amount of liens on the home is not more than 33% of the value. The home must have insurance coverage, and flood insurance if necessary, with WHEDA being permitted to be a lienholder on the policy.

There were only 78 loans made in 2008, down from a peak of 486 in 1993. The drop is due to changes in the program such as a \$75 fee for a title search and a change to how the interest rate is calculated (not to mention the title search discovering some households didn't qualify due to other liens on the home). This program can be used for special assessments as well.
