Medicaid is a vital safety net for over 1.1 million Wisconsinites: working families, older adults, and adults and children with disabilities including mental illness, developmental disabilities and physical disabilities.

#### Frequently Asked Questions

1. I am on Family Care/IRIS. Will my Medicaid go away if the Governor's budget is passed?
2. What does a “freeze” on Family Care mean?
3. When will the Medicaid audit occur? What will happen as a result of the audit?
4. My county has not yet gotten an Aging and Disability Resource Center. Will we still get one in spite of the “freeze” on Family Care?
5. What do the Medicaid changes in the past budget repair bill mean?
6. Is Medicaid scheduled to be cut as part of the Governor's proposed budget?
7. Will I lose my prescription drug coverage through Medicaid if the budget passes? (con't)

8. Will people with disabilities lose their long-term care supports through Medicaid if the budget passes?
9. Does the Governor's budget call for people with disabilities to pay more for Medicaid?
10. How do I share my concerns about potential changes to Medicaid with policy makers?

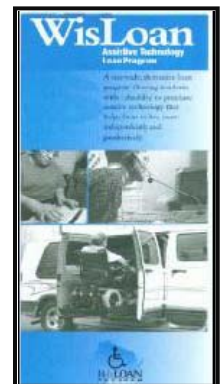

## WisLoan and Teletwork Programs

The Wisconsin Teletwork Loan Program is a statewide, alternative loan program that allows Wisconsin residents with disabilities to purchase computers and other equipment needed to work from home or from other remote sites away from the office, such as work on the road or at a Teletwork center. The WisLoan program offers loans for assistive technology. The loans help people buy equipment such as hearing aids, modified vehicles, wheelchairs and ramps. The program is open to Wisconsin residents of all ages who have a disability. There are no income requirements, and individuals are not required to exhaust



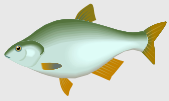
personal or public funding. Under the program, banks provide loans at a fixed rate of 6.5% to qualified borrowers. Loan amounts depend on the item purchased and the ability to repay the loan.

New items in the loan and demonstration program! If you are interested in trying or learning more about the devices in our program (over 2000 devices) please call the Center

**The Wilson Recorder:** Simple to use (only 3 buttons) digital recorder can store an unlimited number of messages up to 5 hours of recording time. Messages can be easily added or deleted and can be transferred to your computer using an included USB cable.

**Vision Booster Magnifier for low Vision:** Read fine print more easily and see family photos clearly. Easily connects to any computer monitor and allows you to view text and pictures magnified up to 24x on the screen. It's a handy, yet inexpensive device that makes it easier for those with low vision to view maps, recipe cards, crossword puzzles, medicine bottles, pictures, newspapers, books and magazines. Simply plug the Vision Booster into the USB port of your existing computer and place the mouse-shaped device on top of the print or image you want to view. It will magnify 12-point type to 1" high on a 17 monitor. The zoom function increased it up to 3" high. Requires USB 2.0 and Windows XP or Vista operating system; not compatible w/Windows 7.

**EZREAD Electronic Magnifier:** Simply place the ezRead directly on top of your reading material to display the magnified image in full color right on your television screen. Easily connects to the video input of your television in seconds using the supplied video cable. Internal LED illumination ensures that the image on the screen is bright and easy to read. The size of your television monitor determines the actual magnification of the item. The larger the monitor, the greater the magnification. Extra-long (nearly 11' video cable) allows you to sit a comfortable distance from the TV.

**Easy Slice Folding Mandoline:** Makes slicing all of your favorite vegetables and fruit quick and easy. It features a serrated stainless steel blade that is adjustable at the simple turn of a knob to provide four slicing thicknesses (1/32, 1/16, 3/16 and 1/4), plus an additional julienne option (5/16) gives you the perfect matchstick (french fry) cut. The included food holder gives you better control and keeps hands and fingers safely away from blade. A non-skid rubberized base and built-in stand keep the mandoline secure and in optimum cutting position.

**Clarity® XL2™:** Cordless phone provides loud and clear sound while keeping things simple. 50dB of amplification, tone control, speakerphone in handset, large buttons, loud 95dB ringer with visual indicator, talking caller ID/ talking keypads and more.

**Amplicom Power Tel 680™ Amplified Corded Phone with Cordless Handset and Wrist Shaker:** DECT 6.0 technology, 50dB of amplification, answering machine in corded base, tone control, speakerphone, loud 90dB ringer with visual indicator, and more. Wrist shaker vibrates in the event of an incoming call.

**Apple I pad 2:** It is a touch screen tablet that one can use to read books on, surf the internet, watch movies and many other things. We have purchased applications for it to assist a person for speech communication, budgeting, taking notes, organizing shopping lists, taking medications and more. This item is for demo only, we would be happy to spend a few hours with you to explore its uses.

## TEPP OUTREACH GRANT 2011

The Center for Independent Living for Western Wisconsin received a grant from Wisconsin's Universal Service Fund program. The purpose of this grant is to promote awareness of the Telecommunications Equipment Purchase Program (TEPP) and to demonstrate specialized telecommunication equipment to people with disabilities, service providers and the community at large. CILWW maintains a device Loan and Demonstration Program which has specialized telephones and communication devices available for a person to try out to determine what works best for them. Staff will assist with TEPP applications or provide information on purchasing equipment.

We are ordering new phones and accessories to offer more options. ### **The Medicaid Purchase Plan:** What is Medicaid Purchase Plan (MAPP)?

The Medicaid Purchase Plan (MAPP) offers people with disabilities who are working or interested in working the opportunity to buy health care coverage through the Wisconsin Medicaid Program. Depending on an individual's income, a premium payment may be required for this health care coverage.

***What are the eligibility requirements?*** To qualify for MAPP, the following requirements must be met. The participant must:

- Be at least 18 years old.
- Reside in Wisconsin
- Have individual countable assets of less than \$15,000. (Countable assets including savings, life insurance policies, stocks or bonds. Non-countable assets include a home, a vehicle, and personal property.)
- Be determined (by the Department of Health and Family Services' Disability Determination Bureau) to have a disability.
- Have an adjusted family income of less than 250% of the federal poverty level.
- Be employed in a paid position or be enrolled in a certified Health and Employment Counseling (HEC) program.

### ***What is the work requirement for MAPP?***

A person meets the work requirement for MAPP if engaged in a work activity at least one time per month for payment. Payment for work activity can be money or an "in-kind" benefit. An "in-kind" benefit is an item that may be used to meet a person's food or shelter needs

### ***What is the Health and Employment Counseling (HEC) program?***

The Health and employment counseling (HEC) program is a way to gain Medicaid healthcare coverage while planning for employment. MAPP\_HEC Specialist are available to help develop an employment plan. By developing a plan that is approved by the Department of Health Services (DHS), a HEC participant can enroll in MAPP for 9 months. Application for MAPP must be made prior to developing a HEC plan for employment.

## **New ADA Regulations are now In Effect**

The Department of Justice's revised Americans with Disabilities Act (ADA) regulations, which apply to businesses of all sizes that serve the public, took effect on March 15<sup>th</sup>.

The amended regulations contain many new or revamped provisions on general nondiscrimination policies. The new nondiscrimination provisions, except for those addressing hotel reservations, take effect immediately. Compliance with the hotel reservation provisions is not required until March 15, 2012. The rules also include the 2010 Standards for Accessible Design (2010 Standards), which provide new and revised technical requirements for building accessibility. Newly constructed and altered facilities must be built in compliance with the 2010 Standards beginning March 15, 2012.

The Department has developed a guide to assist small businesses to understand their obligations under the revised rules. *ADA Update: A Primer for Small Business* is an illustrated guide with easy-to-understand language that provides an overview for complying with the revised regulations.
